# **FISHER FORUMS**

Fisher forums continue to provide a valuable opportunity for open discussions with fishers throughout our district. In the latest round, valuable insights have been gained about the current concerns and issues facing fishers, including the impacts from the winter storms, ML5 medical certification process and other general fishing industry pressures.

Fishers also provided their thoughts and ideas for enhancing and sustainable developments for the local fishery including, successful trawl gear trials to reduce discards as well as being supportive of seeing the NIFCA V-notch programme restarted. These meetings also gave NIFCA officers the chance to ask fishers what they think about recent consultations and feeding back with updates on national work including Fishery Management Plans.

Further meetings are planned in the next year at ports previously not visited. We hope to be joined by other organisations, including the MMO. Look out for a summary of topics and issues discussed, plus what resulting actions and further work is being carried out from these sessions, which will be hosted on our website under the Fisher Forum menu.





# NATIONAL FISHERY MANAGEMENT PLANS

FMPs are national 'action plans' for the management of individual fisheries and will be developed collaboratively with the fishing industry and other stakeholders.

The plans could change management measures in your fisheries, so it is important to stay up to date and where possible, give your views to feed into the development of the plans as part of the process. Consultations closed in October 2023 for Tranche 1 and 2 with the first 5 plans published in December.

### AUTHORITY WELCOMES NEW ENVIRONMENTAL OFFICER

#### (NIFCA) is pleased to announce the appointment of a dedicated Environmental Inshore Fisheries and Conservation Officer.

Vicky Rae joined the team to further strengthen the Authority's role in protecting and conserving the local marine environment in the NIFCA district.

As an environmental officer, Vicky will be responsible for a range of important tasks, including working closely with local communities, fishermen, and stakeholders to promote sustainable practices as well as responding to marine licences and consents and supporting the environment team more widely.

Vicky's experience will be an asset to NIFCA as we work closely with the local community and stakeholders to ensure the responsible management of Northumberland's inshore fisheries and a sustainable and thriving marine environment.

### **STUDENT PLACEMENT**

Over the summer, we welcomed Eleanor, who joined us for 6 weeks as part of our NIFCA Summer Placement. During her time with us, Eleanor joined us for a mix of sea patrols and survey work, as well as assisting with the analysis of the data back in the office. We'd like to thank her for the contributions she made over her time with us and wish her success in the future.



# **RESEARCH WORK**

The environmental team completed their annual mussel surveys with the reports available on the website. Periwinkle surveys have continued at sites across the district with the final two surveys completed in November and the results will be analysed and published of Spring 2024. Biannual fish surveys at the Aln estuary provided some great data with a high number of juvenile herring and European eels found.

NIFCA has used its SeaSpyder camera for two projects during the summer. The first was contract work for Cefas in the Berwickshire and North Northumberland Coast SAC, with some groundtruthing work in Coquet to St Mary's MCZ.



NIFCA also surveyed the release site for the Wild Oyster project, with plans to repeat this survey with the oysters now on the ground. Poor visibility underwater with winter conditions has prevented this to date.







As well as the ongoing monitoring work undertaken, offshore sampling by officers also continued on several fishing vessels, where the team collected biometric shellfish data of lobster and crab to further add to the data held in these fisheries. A big thank you to all those fishers who facilitated this important work.



## **RESEARCH AND SURVEY EQUIPMENT**

To further develop our survey capabilities, NIFCA recently purchased HYPACK software which will provide officers with a platform to plan, design and run future surveys.

As well as helping to plan surveys more effectively, the software continuously logs metadata such as speed and course overground. It can also more accurately capture the GPS position of the camera than from taking the position of the boat, improving the quality of the data collected. Preparatory work using this software was part of the initial pre-deployment survey work undertaken for the local Wild Oysters Project.

Additional support in the way of training was provided by our partner Cornwall IFCA which incorporated the Hypack training with the addition of a sidescan system that was beneficial for future acoustic surveys. Hypack proved to be a great success and the survey went smoothly, it is planned to run further surveys to continue to improve the data quality and outputs.



NIFCA has also made upgrades to our existing remote-operated vehicle (ROV) in the form of a FiFISH V6 Expert device that will further strengthen our existing survey capabilities.

This omnidirectional ROV will be an important survey asset going forward and will be utilised as part of several surveys monitoring sensitive habitats and inspecting fishing gear in-situ.

# **OIL SPILL TRAINING**

Environmental IFCO Katy Smart along with Lead Enforcement IFCO Nick Weir attended a day's training on Oil Spill reaction at Seahouses harbour. The course was provided by Briggs Marine & Environmental Services Limited.

The main objective was to familiarise attendees with the different tools and equipment used during a first response and deploying these safely and efficiently. By the end of the course, both officers were familiar with the oil spill prevention measures from classroom presentations and able to take part in a practical exercise in the harbour by launching booms and skimmers. Further training in this area has also been completed with officers attending an MCA Beachmaster course as well as taking part in a training exercise with the Port of Tyne.

# **SPECIES CHALLENGE**

NIFCA launched its first Pilot Recreational Sea Angling competition in May 2023 to learn more about what fish species are present in the district throughout the year.

The entries did not disappoint, with more than 60 competitors submitting catches. The winner was announced in January and presented with a cheque for  $\pounds150$ . Following the feedback

from 2023, we are now running a bigger and better angling species competition this year, introducing monthly prizes, a larger overall winner's prize and an active leaderboard. 
### NIFCA SPECIES CHALLENGE 2023 RESULTS

#### **FISH SPECIES CAUGHT**

During the competition's timeline between May and December, a cracking 20 different species were submitted! Some people not competing were even happy to share their unusual finds including shad and bonito! A comparison of the different fish species submitted to NIFCA between May to December 2023



September was the best month for the number of different species being caught. (11 different species recorded). While the highest number of fish submitted was in May.

# PROSECUTIONS

#### Commercial Fisher Fined for National Fisheries Legislation

In January 2024 NIFCA successfully prosecuted Michael Denton Senior of Newbiggin for breaching national fisheries legislation. Mr Denton Snr, the shellfish permit holder of the Talisman II from Blyth retained 179 undersize lobsters in two distinctive keep boxes off Cambois before the vessel headed into Blyth Harbour. After landing, the vessel's catch was inspected and found to contain 11 undersized lobsters on the 18th of July 2022. Mr Denton Snr was found guilty by magistrates at the North Tyneside Magistrates Court of two separate fisheries offences and ordered to pay a total of £2400.

### Recreational Fisher Prosecuted for Four Offences

In October 2023 NIFCA successfully prosecuted Michael Denton Junior of Newbiggin for Breaching NIFCA's byelaws. On the 13th of October 2022, Mr Denton Jnr a recreational permit holder fished with more than five pots, took 21 undersize lobsters, three of which were berried, and had taken more than two lobsters in one day. Mr Denton was found guilty of four offences and ordered to pay £1072.

### Commercial Fisher Disqualified for Breaching Fisheries Legislation

In January this year, Mr Charles "Michael" Denton of Newbiggin by the Sea, was found guilty of breaching local fisheries legislation during an incident in March 2023 when Mr Denton retained and landed an egg baring Lobster.

After hearing evidence from an enforcement officer, the Bench found Mr Denton guilty in his absence. Noting Mr Denton's high degree of culpability despite reasonably low harm to the fishery in this instance, as well as his previous convictions for fisheries offences, the Bench agreed to NIFCA's request to disqualify Mr Denton from holding a shellfish permit to fish for 12 months, also ordering him to pay a fine of £480.00, a further £1,800.00 in prosecution costs and a victim surcharge of £192.00.

### Commercial Fishers Fined for Breaching Shellfish Permit Conditions

In February this year, NIFCA also successfully prosecuted three members of a family from Blyth and Newbiggin by the Sea, for breaching local fisheries legislation that manages the pot fishery along the Northumberland coast.

In an incident in July 2023 when a fleet of 40 fishing pots operated by the Armstrong family were inspected at sea and found to be missing or have incorrect identification tags attached. Upon inspection, the individual pots either had no mandatory NIFCA pot tags attached or they displayed tags allocated to another vessel owned by the family.


The case was brought against David Armstrong Snr, David Armstrong Jnr, and Christopher Armstong. The three members of the Armstrong family pleaded guilty to the same offence, that they had: 'Fished for specified shellfish using pots without tags issued to the commercial permit holder and named vessel affixed, contrary to NIFCA's byelaw 4. Crustacea and Mollusc Permitting and Pot Limitation.'

To Christopher Armstrong and David Armstrong Snr the owners of the fishing vessel; Wendy Patricia BH22, the court individually imposed financial penalties of a £433.00 fine, a victim surcharge of £173.00 and awarded costs of £1,300. David Armstrong Jnr as master of the vessel was ordered to pay a £300.00 fine, a victim surcharge of £120.00 and to pay £780.00 in costs. In total £5,012.00 is to be paid by the family.
